Approval of this request holds harmless NWC, NWSS, CaterWest, and SSA Group LLC (collectively "Company") from any harm brought about by the transport and/or consumption of outside food or beverage brought into the Venue by Client.

Client understands that Company's liquor license requires that alcoholic beverages may only be dispensed by Company's employees and Client will not bring alcohol into the Venue under any circumstances.

ADDENDUM TO EVENT CONTRACT AND WAIVER OF CLAIMS

Client, _____ hereinafter “**Client**” has hired SSA Group, LLC d/b/a CaterWest, hereinafter the “**Company**” and collectively the “**Parties**” for venue, food and beverage services for the event _____ hereinafter “**Event**” at the National Western Complex hereinafter the “**Venue**” as evidenced by the Event Contract dated _____.

Company is the exclusive food and beverage provider for events at the Venue and does not permit outside food to be brought into or consumed on the property without prior written approval by Company. Outside food is defined as food and/or beverages prepared (ingredients combined, cooked, packaged) and transported to the Venue by any means other than having it provided by Company.

Client has submitted the attached written request, which is incorporated herein, to bring outside food to the Event and Company approves this request upon Company’s signature pursuant to the following terms and conditions:

1. Client may only bring outside food that has been approved and is listed on the attached form.
2. Client understands that Company cannot, and has no obligation to, ensure that Health Department guidelines are adhered to by third parties that have prepared outside food or that the food is handled in a safe manner. Company cannot ensure that third parties have tools in place to track allergens, ingredients, or food handling processes.
3. Client expressly and specifically assumes the risks, including any and all risk of injury, harm, or loss that may be incurred by Client or Client’s guests by consuming food and/or beverage products that are not provided by the Company and holds Company harmless should any injury, harm, or loss arise from the consumption or transport of such products.
4. Client fully and forever releases and discharges Company from, and expressly waives, any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that may arise from Client’s transporting or consuming outside food or beverage at the Event. Client agrees not to make or bring any such claim or demand against Company, and fully and forever releases and discharges Company from liability under such claims or demands.
