One (1) Prize Option #1 winner will receive an experience package for two (2) people, Prize Option #1 winner and one (1) guest, to participate with ODFW biologists as they conduct their annual population survey on rocky mountain goats in the Elkhorn Mountains of eastern Oregon. Prize package includes meals and one (1) night lodging. **The ARV of Prize Option #1 is: \$400.**

Prize Option #1 Special Conditions:

- Prize Option #1 winner and their guest are responsible for their own transportation to and from the meetup location in Baker City, Oregon at a time specified by ODFW, in its sole discretion. Round-trip transportation will be provided to Prize Option #1 winner and their guest to/from the meetup location in Baker City, Oregon to the survey location.

- Dates and timing of the experience will occur on dates and times to be determined by ODFW, likely in July or August 2026, in the afternoon/evening on the first day and the following morning on the second day.
 - ENTRANTS UNDERSTAND AND AGREE THAT THE RECEIPT AND/OR USE OF PRIZE OPTION #1 IS OFFERED IS AT THEIR OWN RISK.  - Prize Option #1 winner and guest will be provided binoculars and spotting scopes during the experience. Prize Option #1 winner and guest will be responsible for bringing their own weather appropriate clothing and/or gear.
- b. **Prize Option #2 / Fishing Research in the Marine Reserves Experience:** There is one (1) Prize Option #2 Prize available to be won. One (1) Prize Option #2 winner will receive an experience package for two (2) people, Prize Option #2 winner and one (1) guest, to fish with ODFW staff on a hook and line survey (scientific research method used to study and monitor fish populations by catching them with traditional fishing rods and lines, allowing researchers to collect data on species, size, and abundance) in Oregon's Cascade Head Marine Reserves. Experience will last approximately 8-hours on a small fishing vessel and will include lunch. **The ARV of Prize Option #2 is: \$250.**

Prize Option #2 Special Conditions:

- Prize Option #2 winner and their guest are responsible for their own transportation to and from the meetup location in Port of Garibaldi, Oregon at a time specified by ODFW, in its sole discretion.

- Date of the experience will occur on a date in 2026 to be determined by ODFW in its sole discretion. The date of the experience will be scheduled 1 to 2 weeks in advance but rescheduling, as well as short notice cancelation is possible.
- ENTRANTS UNDERSTAND AND AGREE THAT THE RECEIPT AND/OR USE OF PRIZE OPTION #2 IS OFFERED IS AT THEIR OWN RISK. SOME OF THESE INHERIT DANGERS AND RISKS INCLUDE BUT ARE NOT LIMITED TO: SEA SICKNESS, HEATSTROKE, DEHYDRATION, FATIGUE, OVEREXERTION, DROWNING WHILE ENGAGED IN BOATING, FISHING AND WADING; INJURIES RECEIVED FROM MECHANICAL OR MOVING BOAT PARTS; INJURIES RECEIVED FROM FISHING EQUIPMENT OR RECEIVED FROM OTHER'S USE OF FISHING EQUIPMENT; INJURIES FROM ENCOUNTERS WITH WILDLIFE AND/OR INSECTS; INJURIES FROM EXPOSURE TO SUN, WIND, WEATHER AND/OR OTHER NATURAL ELEMENTS OR ACT OR OMISSION OF ANY GUIDE CONNECTED WITH THE EXPERIENCE. FURTHER, ENTRANTS ACKNOWLEDGE AND ACCEPT THE RISK THAT RAPID MEDICAL ATTENTION AND/OR EMERGENCY RESPONSE MAY NOT BE AVAILABLE AND THAT THERE ARE NATURAL FACTORS AND OCCURRENCES WHICH MAY IMPACT ON OR AFFECT THE SAFETY OF SUCH ACTIVITIES, AND ENTRANTS ASSUME THESE RISKS AND DANGERS. IMPORTANT: The experience will not be interrupted due to normal sea sickness symptoms.

The total ARV of all prizes available to be won in Sweepstakes: \$650. There is a limit of one (1) prize per person. Odds of winning will depend upon the total number of eligible Entries received per selected prize option.

- a. **Prize Option #1 Prize Pool:** Entrants that selected “Rocky Mountain Goat Survey” or “Sign me up for both” when submitting their Entry will be included in the random drawing for Prize Option #1. One (1) potential Prize Option #1 winner will be selected from this prize pool.
 - b. **Prize Option #2 Prize Pool:** Entrants that selected “Fishing Research in the Marine Reserves” or “Sign me up for both” when submitting their Entry will be included in the random drawing for Prize Option #2. One (1) potential Prize Option #2 winner will be selected from this prize pool.
8. **WINNER NOTIFICATION & VERIFICATION:** Each potential prize winner will be notified by the Sweepstakes Administrator, via email and/or phone, and will be required to sign and return, within five (5) days of notification, an Affidavit of Eligibility, a Liability Waiver, and where allowable, a Publicity Release (collectively, "the Releases"). Guest of winner will also be required to sign a Guest Liability & Publicity Release. Noncompliance will result in disqualification and an alternate winner may be selected.

- 12. DISPUTES:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Cuyahoga County, Ohio and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction.
