

## **Marketplace Events Hawaii Build & Beach Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, MUNICIPAL AND PROVINCIAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The "Hawaii Build & Beach" Sweepstakes (the "Sweepstakes") begins at 12:00 a.m., Eastern Time ("ET") December 9, 2024 and ends at 11:59 p.m. ET on December 7, 2025 ("Sweepstakes Period"). All mail-in entries need to be postmarked by November 21, 2025 and received by December 1, 2025.

Trip package includes round trip, coach air transportation (from major airport nearest winner's residence as determined by Sponsor in its sole discretion) to Kona or Puna, Hawaii. Habitat for Humanity will be providing the accommodations, ground transportation and meals. The package also includes \$500 cash to help pay any additional expenses. The trip to take place between the months of April and December 2026. Grand Prize winner and their guest must fly on the same itinerary and all tickets must be reserved together. The Grand Prize winner is responsible for any additional costs due to reserving any higher priced package or any fee applied as a result of a change in the reservation, etc., and is responsible for all government departure taxes, optional travel insurance, and personal spending. Travel arrangements must be made through agent of Sponsor's choosing. Other restrictions may apply. Trip winner and travel companion must have all necessary identification and/or travel documents required for travel. Trip is not transferable. Average Retail Value (AVR) of this prize is \$5,000.
